Description of necessary first aid measures

Section 5. Fire-fighting measures

Extinguishing media

- Suitable extinguishing media** : Use alcohol-resistant foam, carbonic acid, powder or water mist. Use an extinguishing agent suitable for the surrounding fire.
Unsuitable extinguishing media : Do not use water jet.

Specific hazards arising from the chemical : In a fire or if heated, a pressure increase will occur and the container may burst.

Special protective actions for fire-fighters : Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. Section 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

- For non-emergency personnel** : No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Put on appropriate personal protective equipment.

Methods and materials for containment and cleaning up

- Small spill** : Stop leak if without risk. Move containers from spill area. Solvents should be avoided. Absorb spillage to prevent material damage. Dispose of via a licensed waste disposal contractor.

Section 7. Handling and storage

Precautions for safe handling
